- There will be no refunds or credit notes given if cancellation occurs on or after 20<sup>th</sup> April 2011.
- Unpaid registrations will be liable for payment of the full amount if submitted on or after 20<sup>th</sup> April 2011, even if cancellation of the registration is made by the delegate.
- By submitting a registration form to attend one or more events, you have agreed to the registration fee. If you wish to cancel your place and have registered, but not paid to attend the conference day(s) you must notify us in writing before the 20<sup>th</sup> of April 2011 of your decision to cancel, otherwise you will be charged the full agreed price.
- All fees owing need to be paid in full before the commencement of the conference unless special arrangement has been made with Neil Porter, conference organiser. Once the conference is over, all fees associated with collecting payment will need to be met in addition to the payment of monies owed.
