Terms and Conditions

- Submission of a completed registration form is a binding commitment to attend the conference day(s) and pay the agreed fee.
- All fees owing need to be paid to Wise Solutions within 30 days of an invoice being sent out to the delegate(s) elected email address. Conference places may be cancelled by Wise Solutions if invoices are not paid within 30 days of the delegate(s) being sent invoices via email.
- No refunds will be given for cancellation of a paid booking, however, a credit note may be issued, at the discretion of the organisers, to allow attendance at an alternative Wise Solutions event if the booking cancellation occurs before 20th April 2010.
- There will be no refunds or credit notes given if cancellation occurs on or after 20th April 2010.
- Unpaid registrations will be liable for payment of the full amount if submitted on or after 20th April 2010, even if cancellation of the registration is made by the delegate.
- By submitting a registration form to attend “ A day with Jane Elliott” or “Positive Schools 2010 Mental Health and Wellbeing Conference” you have agreed to the registration fee. If having registered, but not paid to attend the conference day(s) you must notify us in writing before the 20th of April 2010 otherwise you will be charged the full agreed price.
- If an individual wishes to take the place of a registered delegate who is no longer able to attend (e.g. another staff member from the same school/organisation) then Wise Solutions must be informed in writing and agree to this before the day(s) of the conference.
- In the event that a registration form is received after all places have been taken for the conference day(s), the registration will be rejected and any monies paid returned. Individuals making unsuccessful submissions may choose to refrain from claiming back payment and have their name added to a waiting list for either or both events
- All travel and parking arrangements are the responsibility of the delegate. The organisers of the event will not be liable for any costs incurred by the delegate.

Every effort will be made to inform delegates of any changes that occur to the program before the event(s) but no refunds will be issued on the basis of changes that are made.

All fully paid delegates will be emailed notification of the timing and availability of workshops prior to the conference. Delegates will then have the opportunity to register for the workshops of their choice online via the conference website over a specified two week period. Delegates may still register for any remaining workshop places after the allotted two week period, until all places have been filled.
